Tenders must be accompanied by valid:

- (i) Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender.
(applicable to local firms)
- (ii) Certificate of Compliance issued in accordance with the National Insurance Act.
(applicable to local firms)

The original and four (4) copies of the Tender should be placed in sealed envelopes clearly marked on the outside:

Late tenders **will not** be considered in any circumstances.
